WAGS 'N WHISKERS DISCLAIMER

PLEASE READ CAREFULLY.

It affects any rights you may have if you, your dog(s) or cat(s), or anybody you bring along to daycare reinsured or otherwise suffer damages while participating in daycare and boarding at Wags 'N Whiskers. It also states your responsibilities regarding fees and expectations associated with daycare and boarding at Wags 'N Whiskers.

I, _____ (participant/guardian of dog(s) and/or cat(s)) hereby agree to the following covenants described below regarding the daycare and boarding programs at Wags 'N Whiskers. Further release, waive, discharge and covenant not to sue Wags 'N Whiskers and any of the officers, servants, agents, employees and volunteers of the above-mentioned entities (hereinafter referred to as RELEASEES) for any liability, claim and/or cause of action arising out of or related to any loss, damage or injury, including death, that occurs as a result of my participation in the below-described activities.

1. Participation in daycare and boarding is voluntary. We reserve the right to excuse any dog and/or cat from daycare or boarding at any time for negative behavior.
2. It is the participant's choice to bring other people to the daycare area at his or her risk and it is the participant's sole responsibility to ensure their safety and well-being.
3. RELEASEES do not guarantee a dog's and/or cat's behavior at any time, during or outside of daycare and boarding. We can only evaluate and supervise to the best of our ability.
4. I further understand that Wags 'N Whiskers has relied upon my representation that my dog(s) and/or cat(s) is in good health and has not injured or shown aggression or threatening behavior to any person, dog, or cat in admitting my dog and/or cat for services at their facility.
5. Participating dogs are to be current on their vaccinations. We require a current DHPP/FVRCP vaccine (1 or 3 year), Bordetella (6 month for dogs, annually for cats) and Rabies vaccine (1 or 3 year) if the dog and/or cat is old enough. By signing this agreement you certify that your dog is current on his/her vaccinations. We also require participating dogs to have a negative fecal exam every year. In addition, I decree that, to the best of my knowledge, my dog(s)/cat(s) are not currently ill/being treated for contagious infection(s)/disease(s).
6. All dogs over 18 months must be spayed or neutered if attending daycare. I understand that if my dog(s) and/or cat(s) are not spayed or neutered while at Wags 'N Whiskers they are at risk of becoming pregnant or mating with another dog or cat. I further understand that Wags 'N Whiskers will not be held responsible for a dog's or cat's pregnancy.
7. RELEASEES are not responsible for any incident or accident arising from the travel to the daycare and/or boarding sessions or after leaving daycare and/or boarding, nor are they responsible for any incident or accident from the travel to and from an offsite facility.
8. Wags 'N Whiskers hereby has permission to use any photos taken of you, your dog(s) and/or your cat(s) during class and/or boarding for advertising purposes.
9. Daycare dogs will be supervised at all times. However, any time groups of dogs play off leash together there is a chance for injury. By signing below I'm giving permission for my dog(s) to play off leash with other dogs and play on agility equipment while in the daycare facility (if attending). I understand that there are risks and benefits associated with group socialization of dogs. I agree that the benefits outweigh the risks and that I accept the risks. I desire a socialized environment for my dog while attending the services provided by Wags 'N Whiskers and while in their care. I understand that while the socialization and play are closely monitored by Wags 'N Whiskers staff to prevent injury, it is still possible that during the course of normal play my dog may receive minor nicks and scratches from roughhousing with other dogs.
10. I further understand that RELEASEES will not be liable, financially or otherwise, for injuries to my dog(s) and/or cat(s), me or any property of mine while my dog(s) and/or cat(s) is participating in services provided by Wags 'n Whiskers. I hereby release Wags 'N Whiskers of any liability of any kind arising from my dog(s) and/or cat(s)'s participation in any and all services provided by Wags 'N Whiskers.
11. I further understand that I am solely responsible, financially or others, for any harm or damage caused by my dog(s) and/or cat(s) attending any services by Wags 'N Whiskers.
12. I further understand and agree that any problems with my dog(s) and/or cat(s), behavioral, medical or otherwise will be treated as deemed best by staff of Wags 'N Whiskers is their sole discretion, and in what they view as the best interest of the animal. I understand that I assume full financial responsibility and all liability for any and all expenses involved in regards to the behavior and health of my dog(s) and/or cat(s).

13. I understand that if my dog(s) and/or cat(s) is not picked up on time or by a date specified in this agreement I hereby authorize Wags 'N Whiskers to take whatever action is deemed necessary for the continuing care of my dog(s) and/or cat(s). I will pay Wags 'N Whiskers the cost of any such continuing care upon demand by Wags 'N Whiskers. I understand that if i do not pick up my animal, Wags 'N Whiskers will proceed according to guidelines provided by Jefferson County, AL Animal Services. I also acknowledge that I will be fully responsible for all attorneys' fees and associated costs if i abandon my dog(s) and/or cat(s).
14. I understand that if food is not provided by me for my dog(s) and/or cat(s) the animal will be fed by Wags 'N Whiskers. I also understand that Wags 'N Whiskers is not liable if the food provided to my animal by Wags 'N Whiskers herein makes the animal sick.
15. I understand that Wags 'N Whiskers will not be held responsible if my dog(s) and/or cat(s) become ill from their time attending Wags 'N Whiskers' services. Further, Wags 'N Whiskers will not be responsible for paying any fees associated with the illness caught by the animal.
16. I understand if my dog(s) and/or cat(s) are under the age of 15 weeks they are not fully vaccinated. Further, I understand that if they participate in daycare and/or boarding under the age of 15 weeks Wags 'N Whiskers will not be held responsible for any illness and/or damages that occurs as a result.
17. I agree to maintain regular flea, tick, and heart worm preventative maintenance programs for as long as my dog(s) has/have active attendance and participation at Wags 'N Whiskers.
18. I understand that payment is due upon completion of service(s) rendered.
19. A deposit of \$50.00 is required for all holiday stays. The deposit will be applied to the final bill at the time of pick up/ check out. I Understand that a spot in the boarding during the holiday hours will only be reserved upon payment of the deposit. Holidays are defined as follows:
 - The period beginning the Friday immediately before the Spring Break Holiday designated in the Homewood City Schools' yearly calendar through and including the Sunday following this period.
 - The period beginning the Thursday immediately before Easter Sunday through and including the first Monday following Easter Sunday
 - The period beginning the Thursday immediately before Memorial Day through and including the first Tuesday following Memorial Day
 - The period beginning July 1 through and including July 10
 - The period beginning the Thursday immediately before Labor Day through and including the first Tuesday following Labor Day
 - The period beginning the Sunday before Thanksgiving through and including the Monday following Thanksgiving
 - The period beginning December 20 through and including January 8
